Dr. Andrew Morrow, Assistant Superintendent for Administration, reported to the Board on the Capital Improvement Plan for 2018-19. Presenting alongside Dr. Morrow was Mr. Robert Palmer, Director of Plant Services. It was noted that the Proposed Capital Improvement Plan (CIP) will be adopted by the Board at the February 6, 2018 meeting and forwarded to the Town Manager. <http://www.whps.org/boardofeducation/agenda>. Discussion included highlights of 2017-18 CIP as well as the upcoming building maintenance projects sited for 2018-19 through 2020-21. Questions were asked by the Board on how any unforeseen problems that come up during the year are addressed, and how the needs of the schools are requested and prioritized. In addition, the proposed Board request for funding to study the addition of air conditioning to elementary schools was discussed. Board members shared concerns over the expense of such a project with limited funding and impact, and decided to remove the funding from the 2019-20 to 2029-30 period.

Mr. Pauluk moved and Mrs. Blanks seconded:

Superintendent Tom Moore congratulated Abby Esposito, US History Teacher at Conard, for receiving a grant from the Mohegan Tribe, and also gave thanks to Chalise Ross, ESOL's Townwide Curriculum Specialist, for putting together this year's Variety of Home Languages Report. This year 74 different languages are spoken in homes throughout West Hartford, up from 72 last year.

Mr. Paul Vicinus, Assistant Superintendent for Curriculum, Instruction and Assessment, introduced and presented on Teaching Religion in West Hartford. Panel presenters included Ms. Kerry Jones, Director of Elementary Education, Ms. Jessica Blitzer, Townwide Department Supervisor for Social Studies for grades 6-12, and Ms. Ashley Callan, Townwide Elementary Curriculum Specialist for Social Studies and Language Arts.

Ms. Jones-provided background information on the two relevant Board of Education policies that inform teaching about religion. Board of Education Policy #6326 Instruction about Religion states that while we "will not promote or advance any particular religion, ... we will provide neutral, objective, curriculum-related instruction regarding the development and influence of the major religions of the world." Board of Education policy #6211 Cultural Diversity states that our "instructional program will value, recognize, and address the needs of all children as well as promote student understanding of and appreciation for cultural and individual differences."

Ms. Jones also shared the National Council for the Social Studies (NCSS) College, Career, and Civic Life (C3) Framework which outlines the four disciplines of social studies learning: history, geography, civics, and economics. West Hartford educators were core members of the state social studies framework writing team which developed the Connecticut Social Studies Frameworks. While the state social studies frameworks do not offer specific guidance on instruction

about religion, Ms. Jones highlighted that our Board of Education policy is aligned with widely accepted guidelines for teaching about religion that include an academic non-devotional study about religion that neither promotes nor denigrates religion or conformity to particular beliefs.

Ms. Jessica Blitzer spoke on the professional learning practices in West Hartford related to teaching about religion. She noted that teachers at the secondary level have had the opportunity, along with other districts, to participate in training on how to teach religions in public schools. Ms. Blitzer was one of the authors of the Religious Studies Companion Supplement to the C3 Framework, a new resource developed by the NCSS to inform state educational bodies, districts, schools, and teachers at the high school level as they consider how to teach about religions. Ms. Blitzer explained that West Hartford teachers also played a role this year in drafting a Companion Document for religious studies at elementary and middle school levels. West Hartford middle school curriculum is in process of shifting to the inquiry model of the C3 social studies framework. The Department will determine how to most effectively embed study about religion within social studies courses at the secondary level.

Ms. Ashley Callan spoke on instructional guidance for elementary schools. At the elementary level, social studies curriculum is being revised. This year, fourth and fifth grade curriculum includes lessons for teaching religion integrated with social studies content and aligned with Board of Education policies regarding cultural diversity and religious instruction. K-3 curriculum on teaching religion will be revised over the next year.

The Board thanked the team for the depth of their report and asked questions regarding how information is delivered to families, the training that is provided for teachers on the diversity of religion, and how districts who also participated in training are doing.
